A Depiction of Civilisation in Crisis takes the 2017 UOB Painting of the Year Indonesia Award

Jakarta, **25 October 2017** – PT Bank UOB Indonesia (UOB Indonesia) today presented the 2017 UOB Painting of the Year Indonesia Award to Mr Kukuh Nuswantoro for his art work titled *Kegelapan* or translated as *Darkness*.

The winning painting, in the style of neo-expressionism, presented modern civilisation in a state of crisis. It was chosen from among four finalists in the Established Artists category at this year's UOB Painting of the Year Indonesia competition. The 51-year old artist impressed the panel of judges comprising art experts and curators. They were Mr Agung Hujatnikajennong – Independent Curator and Lecturer at Bandung Institute of Technology, Mr Hendro Wiyanto – Art Writer and Independent Curator, and Mr Anindityo Adipurnomo – Artist, Owner of Cemeti and Co-Founder of IVAA (Indonesia Visual Art Archives).

Commenting on the quality of the winning painting, Mr Hujatnikajennong said the artist had expressed his emotional visualisation of the world's evolution and state through an almost raw and brutish manner using intense colours and distorted images.

As part of the competition, Mr Nuswantoro received a cash prize of IDR250 million. His artwork will now compete with the winning entries from Malaysia, Singapore and Thailand for the UOB Southeast Asian Painting of the Year Award¹, which will be announced on 8 November 2017 in Singapore. Mr Nuswantoro also stands a chance to win a one-month residency programme at the Fukuoka Asian Art Museum in Japan.

Explaining his artwork, Mr Nuswantoro said, "I was inspired by the state of modern civilisation along with the many conflicts that are taking place around the world. It highlights the story of human greed and thirst for power that shape society today. Nonetheless I believe we can remain true to our humanitarian values

to foster peace and harmony. I am delighted to receive this award and I look forward to representing Indonesia at the UOB Southeast Asian Painting of the Year Award in Singapore next month."

In the **Emerging Artists**² category, 22-year-old Mr Alvian Anta Putra won the UOB Most Promising Artist of the Year award for his painting titled *Discussion*. His pixelated oil painting portrays a crowd of people in cyberspace. The painting captures how technology has created a cultural shift that makes us virtually close to each other but in reality far apart.

Mr Kevin Lam, UOB Indonesia's President Director, said UOB Indonesia is committed to making a difference in the lives of its stakeholders and in the communities in which it operates, particularly in the areas of art, children and education.

"I would like to congratulate all winners for their achievements. I am pleased to see many new vibrant talents among the submissions from across the country for the UOB Painting of the Year Indonesia competition. Each of their artworks presents a unique sensibility that speaks to our emotions and evokes our own experiences and memories. This reciprocity quality of art is what connects us to one another and to the larger community, thereby enabling greater appreciation of art."

UOB champions art as a key pillar of its corporate social responsibility role. The annual UOB Painting of the Year competition is the Bank's flagship programme. Over the past seven years, the competition has launched the careers of many well-known artists in Indonesia. Indonesian artists have won the UOB Southeast Asian Painting of the Year award four times. The winning paintings from the 2017 UOB Painting of the Year competition will be exhibited at the UOB Art Gallery, UOB Plaza 1 at 80 Raffles Place, Singapore 048624 from 16 November 2017 to end January 2018. UOB Indonesia will also exhibit all winning paintings from Indonesia at the UOB Plaza, M.H Thamrin Street, Jakarta, Indonesia from 26 October to 26 November 2017.
