UOB Indonesia invites emerging and established artists to share their talent at the 5th UOBI Painting of the Year competition

Jakarta, 23 June 2015 – PT Bank UOB Indonesia (UOBI) is inviting Indonesia's emerging and established artists to enter the UOB Painting of the Year competition¹, an annual art event organised by UOBI since 2011.

Mr. Armand B. Arief, President Director, UOBI, said the Bank aims to raise awareness of Indonesian artists and help them realise their full potential through the UOB Painting of the Year competition,

"The UOB Painting of the Year competition is one of the ways for us to identify local artistic talent and to showcase Indonesian art to a wider community. In the last five years, Indonesia has produced two UOB Southeast Asian Painting of the Year award winners, which shows that Indonesian art and artists are wellreceived in the region," said Mr. Armand.

The UOB Group started its annual UOB Painting of the Year competition in Singapore in 1982 and has since extended it to Thailand in 2010, and then Malaysia and Indonesia in 2011. Over the years, the competition has helped discover and nurture emerging artists as they have taken their first steps in their career. It has also encouraged established artists to push their creative boundaries.

The competition has cultivated a strong alumni of Indonesian artists over the last four years. They include Mr Gatot Indrajati, the first country winner in 2011 and his recent work The Puppet State have been exhibited in Indonesia, Singapore, South Korea and Shanghai; Mr Y. Indra Wahyu, the first Indonesian artist to win the UOB Southeast Asian Painting of the Year award in 2012 and who is best known for his watercolor and sketch techniques; Mr Suroso Isur, winner of the UOB Painting of the Year (Indonesia) competition whose artworks have been featured in many art galleries in Indonesia and Mr Antonius Subiyanto, the winner of the 2014 UOB Southeast Asian Painting of the Year award who has gone on to exhibit in numerous cities in Indonesia.

The artists will share their painting techniques with one another and create artworks together with renowned Thai artists Mr Suwit Jaipom and Mr Dinhin Rakpong-Asoke. Mr Jaipom is celebrated for his large crayon paintings and Mr Rakpong-Asoke for his portrait and illustration skills.

Mr Antonius said participating in the art workshop will give him the opportunity to share Indonesian art techniques with his peers in the region and encourage artistic dialogue.

"I am very happy to have the chance to interact with fellow Southeast Asian artists. I look forward to learning new things from them and stimulating my creative thoughts for future art pieces," said Mr Antonius.

Artist Category:

Open to experienced professionals with an established portfolio of work. They must have shown their paintings in solo or group exhibitions (excluding school graduation shows); be represented by a gallery; **or** have achieved recognition through art awards

Criteria for Emerging
Artist Category:

Open to aspiring artists who are pursuing an arts education; are taking their first steps to a career in art; **or** simply paint for pleasure

Categories and prizes:

UOB Southeast Asian Painting of the Year Award: US\$10,000

UOB Painting of the Year Award*: Rp250,000,000

Gold Award: Rp100,000,000 Silver Award: Rp80,000,000 Bronze Award: Rp50,000,000
